This is a needs-based tuition scholarship to help defray the cost of your child's cultural arts education. Friends of Metro Dance offers scholarships at the 75%, 50% or 25% levels based on income documentation provided and are based on the federal guidelines for free and reduced lunch. Scholarship funds are limited and will be available as long as they last for the fiscal year (July 1, 2024-June 30, 2025). You will be notified via e-mail about any scholarship funds you receive. Once awarded, scholarship benefits are applied to your child's classes for the current fiscal year. After that time, you will need to reapply for scholarship benefits with your updated financial information.

This information will be used for the purpose of determining need-based financial aid and shall not be used for any other purpose. The Dance Supervisor will review the applications and will maintain the confidentiality of all information submitted by applicants. Financial documents will be kept in a locked closet and will be shredded at the end of each fiscal year.
